

**TOWN OF CADIZ**  
**MUTUAL AID BOX ALARM SYSTEM AGREEMENT ORDINANCE**

This ordinance is to create an agreement for Mutual Aid for the Browntown, Cadiz, Jordan Fire District with the Mutual Aid Box Alarm System.

The **TOWN OF CADIZ** Board do ordain as follows:

**WHEREAS**, the Constitution of the State of Illinois, 1970. Article VII, Section 10 authorizes units of local government to contract or otherwise associate among themselves in any manner not prohibited by law or ordinance; and,

**WHEREAS**, the “Intergovernmental Cooperation Act”, 5ILCS 220/1 et seq., provides that any power or powers, privileges or authority exercised or which may be exercised by a unit of local government may be exercised and enjoyed jointly with any other unit of local government including a unit of local government from another state; and,

**WHEREAS**, Section 5 of the “Intergovernmental Cooperation Act”, 5ILCS 220/5, provides that any one or more public agencies may contract with any one or more public agencies to perform any governmental service, activity or undertaking which any of the public agencies entering into the contract is authorized by law to perform, provided that such contract shall be authorized by the governing body of each party to the contract; and,

**WHEREAS**, the parties hereto are units of local government as defined by the constitution of the State of Illinois and the Intergovernmental Cooperation Act and the **TOWN OF CADIZ** is a municipality as defined in Section 66.0301(1)(a) of the Wisconsin Statutes and whereby Section 66.0303(1)(2)(3)(b) of the Wisconsin Statutes permits interstate cooperation; and,

**WHEREAS**, the Chairman & Supervisors of the **TOWN OF CADIZ** have determined that it is in the best interest of the Town and it’s residents to enter into an intergovernmental agreement to secure to each the benefits of mutual aid in fire protection, firefighting and the protection of life and property from an emergency or disaster and to provide for communications procedures, training and other necessary functions to further the provision of said protection of life and property from an emergency or disaster.

**NOW, THEREFORE, BE IT ORDAINED** by the Chairman & Supervisors of the **TOWN OF CADIZ**, Green County, State of WISCONSIN as follows:

**SECTION ONE:** That the Chairman and the Clerk be and are hereby authorized to execute an Agreement for participation in the Mutual Aid Box Alarm System, a copy of said Agreement being attached hereto and being made a part hereof.

**SECTION TWO:** That the Mutual Aid Box Alarm System Executive Board By-Laws attached hereto and made a part hereof are hereby approved.
